- ReCAMA Workshop on Trade Procedures and Practices for Agricultural Machinery (6th ReCAMA Training and Study Tour)
 - Co-organized virtually via Zoom on 27 October 2021 at 14:15-15:45 Beijing time by CSAM, China Agricultural Machinery Distribution Association, Association of Indonesian Agriculture Machinery, and Thai Society of Agricultural Engineering.
 - Around 100 participants attended the events from more than 30 countries.
 - Increased awareness about key procedures and practices relating to trade of agricultural machinery in five countries including China, India, Indonesia, Sri Lanka and Thailand; identified information gaps relating to import and export procedures of agricultural machinery and explored ways to address them; and provided exposure to a range of new agricultural machinery and equipment.
